Sick and Tired of Being Sick and Tired

I don't know how you got into the rooms of Alcoholics Anonymous, but I can tell you my story. It wasn't pretty and it wasn't my idea. My idea was to drink myself to death, but it was taking too long. People were starting to notice I was missing a lot of the time. Missing from holiday gatherings, birthday celebrations, the dinner table, and the straw that broke this camel's back... missing from work.

I'd already been put on probation in 2006 for too many absences from my job. I was ordered to attend counseling with our Employee Assistance Program (EAP), and from there it was determined that alcohol was a problem in my life. I chose to go to a local outpatient program for substance abuse while taking a leave of absence from work to try to get my life back together. Now that I look back I can see that this is where it became apparent that my "life had become unmanageable", but I couldn't yet "admit that I was powerless over alcohol". Half-measures avail us nothing, especially when taking the first step where 100% is the goal. So, after being sober for 6 months and attending numerous meetings including A.A., I drank again.

It got worse. A lot worse. Not all at once, but pretty quickly. I drank for 2 ½ more years. This time it was not fun. There was so much shame involved! Shame about the dishonesty and about the failure. I worked hard at keeping the feelings numbed, but it took more and more alcohol to do that. This is the progression of the disease. It is where the addiction becomes physical, where when I stopped drinking to sober up enough to face my responsibilities, my body reacted with shaking, sweating, chills and nausea. I spent hours in the bathrooms at work, took puke bags along on car trips and kept a wastebasket next to my bed. As time went on, I spent more time in bed and less time at work, not even bothering to call in. I was too sick and too tired.

Even with several years of sobriety under my belt, this is hard to revisit. I never expected to end up like that pitiful, incomprehensible creature I had become. Drinking had been about having fun, overcoming inhibitions and taking exciting risks! When had that turned into pain and suffering? Luckily for me, a higher power intervened and sent an angel to help me. She listened. She didn't tell me what to do or make me feel like I was bad. She helped me understand that I was sick and that I could get well. I will always be grateful for this divine grace and try my best to return the gift by helping other alcoholics find the solution to our common problem.

On March 11, 2008, I had my last drink. The next day my friend drove me to 28 days of inpatient rehab. I have found a new life in sobriety as a member of the fellowship of A.A. I celebrate every day I am blessed to wake up. My whole attitude and outlook upon life has changed. I have gone from glass half empty to glass half full and strive to live in the present, one day at a time. I enjoy a host of true friends. My family relationships are being healed. I have found happiness, joy and freedom. Through following a simple program consisting of 12 steps, life has become worth living.


