# **Reports from Officers and Staff:**

**Secretary's report:** Leonard L., recapped the April 8 Minutes. There was no discussion and a motion by Joe, seconded by Jeff, to approve the minutes was passed unanimously.

**Treasurer's Report:** Bonnie reported Group donations received year to date totaled \$10,187.56. The checking account balance as of April 30<sup>th</sup> was \$9,716.42, the Prudent Reserve is \$15,799.93 and Petty Cash \$100.00. She also said that rent and Literature bills of about \$3,000 are due but not yet paid.

Bonnie noted that we have dropped our answering service and canceled a Yellow Page listing for a monthly saving of \$100.00.

Bob commented on our large checking account balance. He said that it is tempting to believe we have an excess of cash. He noted that our recent history suggests a slow down of income toward the end of the year. Also we have an expected expense related to our web site upgrade that is not budgeted. We will be looking at our cash condition at the end of the year.

The Board developed a new program for the Newcomer packages. Our cost to produce them is about \$1.15 and we were selling them for \$0.50. They are now available free for five packages. The Groups can come back when they need five more.

**Literature Report:** Joe E. reported there is an increase in demand for the Spanish literature. He has received a new Grapevine book "Voices of Women in AA" and planning on ordering another new Grapevine book about AA in the Military. He will also be looking at what will be needed for the upcoming Convention.

**Communications Chair:** Jeff L. said that he is not getting any more meeting directory changes and is proceeding with setting up his master directory which will be used for both the web side and printed directories.
