## **COR Reports**

## **Becky B, Mesa Group**

- About 21 in-person meetings, 7 Zoom meetings
- Attendance good; slightly higher than usual
- Financially doing fine; maintaining prudent reserve
- Business meeting held on Wednesday
- **Discussion: AI-Anon meeting request at Mesa Hall**
  - Group conscience was that it would probably not be appropriate
  - Building is exclusively leased for AA meetings; no third party (like an Alano Club)
  - Not allowed to sublet per current contract; could discuss variance with landlord
  - Concerns raised about confusion between AA and AI-Anon meetings, pamphlet racks, and seventh tradition handling
  - Jim L shared experience from Cambria Connection where multiple recovery groups meet; works well but occasional confusion for newcomers
  - Ben shared that ABC Group sublets their room to another meeting, which pays rent to ABC
  - Minority opinion: AI-Anon is connected to AA; should consider accommodating

## **Ben B, ABC Group (Paso Robles)**

- Celebrated 1 year of sobriety on January 29—congratulations!
- Three meetings a day, seven days a week
- Finances improved after adding language about rising costs and appreciating additional donations
- Steering committee meeting next Monday
- About 10 newcomers consistently attending this past month
- Ben took over Friday night meeting; gave up Saturday morning secretary position
- Friday night meeting could use more support

## **Tom (new), Sunday Evening Rap Group**

- New COR representative replacing Jim L; welcomed to the meeting
- Based in Palm Springs but home group is Sunday Evening Rap in SLO

- Been with the group about 5 years
- Meeting at Gala Center in SLO
- Attendance going up slightly
- Meet once a week on Sunday nights
- New people coming in and staying
- Financially in good shape; meeting rent and distributing contributions to Central Office

- Welcome to Tom as new COR representative for Sunday Evening Rap Group; thank you to Jim L for his years of service
- Dick reminded members that you can be a COR representative for more than one meeting; encouraged more participation
